Purposes and legal bases

- A. Verify the functioning of the services and therefore allow navigation: the computer systems and software procedures used to operate this site acquire, during their normal operation, some personal data whose transmission is implicit in the use of communication protocols of the Internet. This category of data includes the IP addresses or domain names of the computers and terminals used by users, the addresses in URI/URL (Uniform Resource Identifier/Locator) notation of the requested resources, the time of the request, the method used in the submit the request to the server, the size of the file obtained in response, the numerical code indicating the status of the response given by the server (successful, error, etc.) and other parameters relating to the operating system and the user's IT environment.
- B. **Statistics**: information is acquired aimed at understanding how the visitor interacts with the site in order to obtain statistics.
- C. **Profiling**: visitor tracking information is acquired so as to outline a profile based on the interests expressed during navigation and, consequently, to propose advertisements in line with the preferences previously detected.
- D. **Respond to communications conveyed through the published contact data**: when the visitor contacts the Owner at one of the contact details published on the site, the information spontaneously transmitted is collected in order to process and process the request.
- **E. Defensive purposes**: the Data Controller may need to process personal data for the management of out-of-court or judicial disputes and disputes.

Data transfer to a third country or an international organization

Rights of interested parties

The subject to whom the personal data refers is granted the following rights:

Access: it is possible to find out whether your personal data is being processed and, if so, to obtain and request a copy of it.

Rectification: it is possible to request the updating of your personal data, their correction (if inaccurate) and the integration of incomplete data.

Cancellation: it is possible to obtain the cancellation of your personal data if certain conditions are met (for further information contact the Data Controller).

Limitation: it is possible to request that the data be marked, so as to limit its processing in the future, if certain conditions are met (for further information contact the Data Controller).

Opposition: it is possible to object to the processing of personal data, for reasons related to your particular situation, where the processing is based on legitimate interest or is necessary for the execution of a task of public interest or connected to the exercise of public powers referred to the Owner is invested.

Portability: it is possible to receive the personal data provided to the Data Controller in a structured format and to transmit it to another data controller if the processing is based on consent or contract and is carried out by automated means.

Revocation of consent: it is possible to revoke consent for the purposes that required it, without prejudice to the lawfulness of the processing carried out up to that point.
